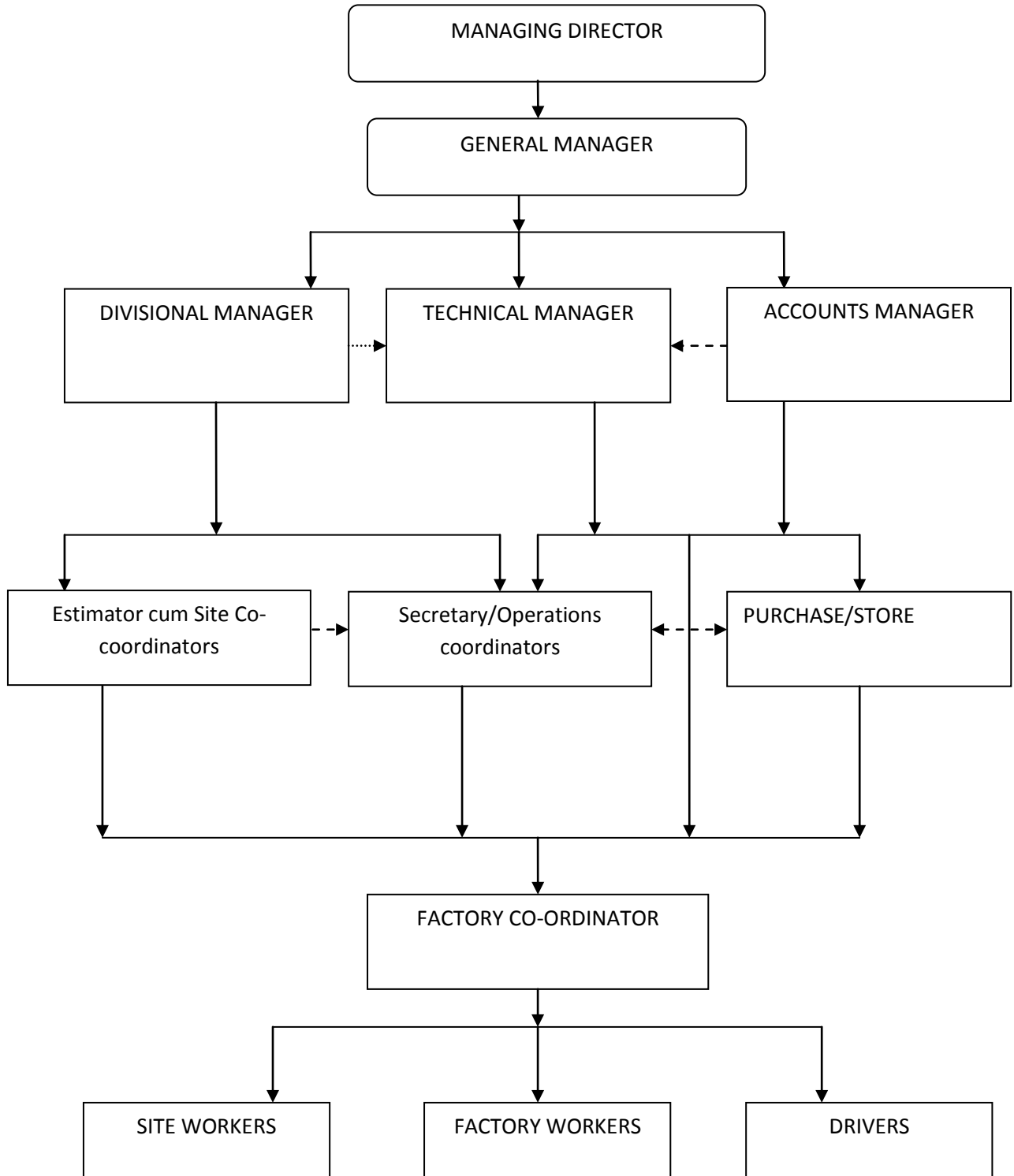

QUALITY CONTROL PROCEDURES

- We are procuring raw material from specified Aluminium extrusions locally & internationally.
- Specified surface metal coating finishes by JOTUN approved applicators in U.A.E.
- Glass & Accessories thru suppliers from approved manufacturer's relevant certificates of Origins.
- Aluminium Extrusions are inspected by the Store Supervisor to ensure the length, type and also the correct shape without twists, bends. (verifies the alloy specifications and certificates)- Visual inspection
- Send for powder coating to Approved applicators of Jotun Powder coating. Under the supervision of Store Supervisor.
- Powder coated material received to the factory sub store will be Inspected for the colour and coating defects by the Factory storekeeper - Visual inspection.
- Profiles are cleaned and rapped with protection tape to prevent from scratches.
- Profiles are cut to required length using Double Miter Saw.
- The cut length sizes are verified– By the Line inspector.
- Milling is done as per the templates and verified for the exact fitting of accessories- n by the Line Inspector.
- The Frame and shutters are assembled by the fitters and sizes and assemblies are verified by the Factory charge hand.
- Glass sizes are crosschecked and verified by Glass Division Supervisor.
- Final Inspection of the Glass Aluminium frames, shutters and accessories by the Q.A/Q.C Inspector.
- Transported to site and stacked at site with wooden/ PVC packing at bottom and polystyrene sheets in between the panels.
- Site Installation of Frame, shutter and Glass – Inspected by Site in charge.
- Inspection after Silicon and fixing of accessories - Site Foreman and Site Engineer.
- Final Cleaning and Handing Over.
